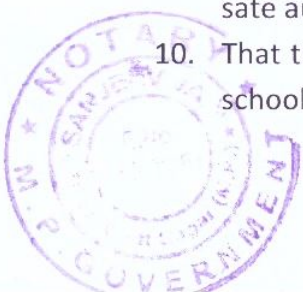


SELF AFFIDAVIT

8. That the school will ensure compliance of all the statutory requirements like EPF, ESI, and Labour Law etc. with respect to the school and staff of the school.
9. That the school will ensure that the Building Safety, Fire Safety, Water Safety Health and Hygiene certificate are being issued or renewed by the concerned municipal or sate authorities from time to time as per the prescribed term.
